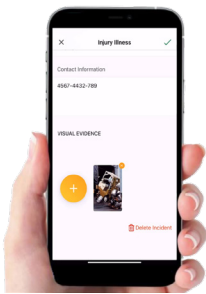


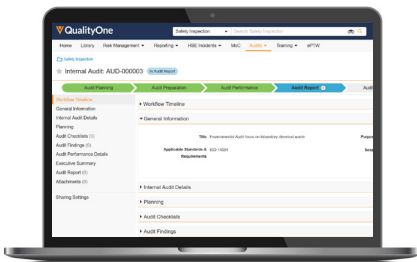

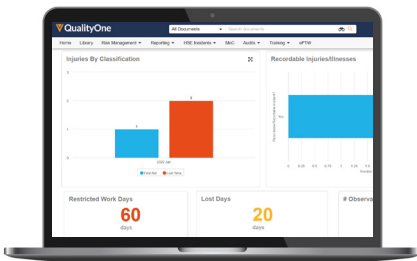
Create a Universal H&S Culture

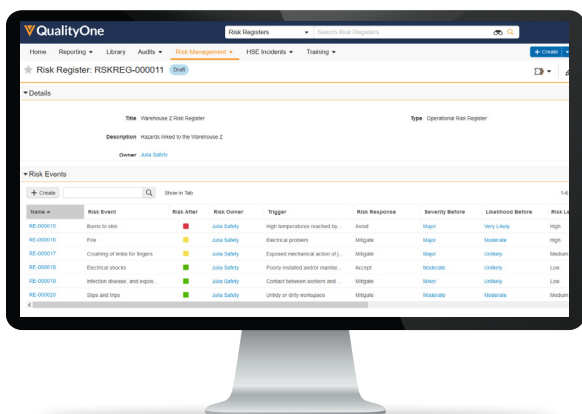
React quickly to events involving health and safety as well as environmental aspects of the organization. Ensure traceability of investigations and actions linked to hazards, near-misses, and incidents.

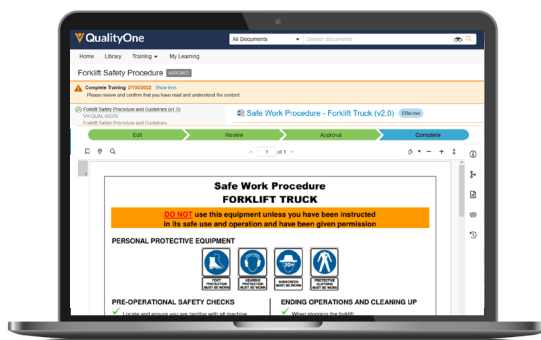
